At the Annual Stockholders' Meeting of PHILIPPINE SEVEN CORPORATION (the "Corporation"), held today, 18 July 2013 at the Sapphire A-B Level 4, Crowne Plaza Galleria Manila, Ortigas Avenue corner ADB Avenue, Quezon City, stockholders representing at least $2 / 3$ of the outstanding capital stock of the Corporation approved and confirmed the resolutions of its Board of Directors dated July 18, 2013, as follows:

- Stock Dividend Declaration of $15 \%$ of the outstanding capital stock of the Corporation of $398,639,411$ shares or equivalent to $59,795,912$ common shares with par value of P1.00 per share.
- Issuance of $59,795,912$ common shares with par value of P1.00 per share from the authorized and unissued capital stock of the Corporation for distribution as stock dividend.
- Any fractional shares resulting from the stock dividend shall be rounded off to the nearest one (1), following the rules of rounding off.
- Record Date for Entitlement to Stock Dividend shall be August 15, 2013, which is not more than thirty (30) days from the approval by the Stockholders.
- Payment Date of Stock Dividend shall be September 9, 2013.
- Granting of authority to any one of the Chairman of the Board, President, Treasurer or Corporate Secretary to file the necessary petition and other requisite documents to secure approvals from the appropriate government agencies and other entities to implement the resolutions.
