 - (c) AHC is engaged in the business of a holding corporation.

AHC is the direct beneficial owner of 30,671,003 common shares or 6.69% of the outstanding capital stock of PSC.

The additional 4,000,566 PSC common shares were acquired/ received pursuant to the declaration of 15% stock dividend by PSC and its distribution on September 09, 2013, the payment date.
